

REQUEST FOR LICENSE AND "THIRTY DAY" INSURANCE FOREIGN TEMPORARY

To return to the French Federation of speleology – 28, rue Delandine – 69002 LYON

The temporary member license is intended for foreign speleologists and canyonists who wish to practice in France for a limited period of 30 calendar days. It provides insurance for this period.

Individual Accident License and Insurance are renewable. The guarantees are different for:

- foreign nationals resident in France benefiting from a French social welfare system: they can subscribe to one of the 3 options provided for in the contract. See page 2 for the summary of the guarantees.

- foreign nationals not resident in France: they can only subscribe to one option (option 1 of the FFS contract) - without daily subsistence allowances. See page 2 for the summary of the guarantees.

In accordance with the Sporting Code - in particular Decree 2016-1157 of 24 August 2016 which supplements Article L. 231-2-3 - and the medical regulations of the French Federation of Speleology, the issuance of a sports license is subordinate to the production of a medical certificate less than one year old attesting the non-contradiction to the practice, specifying the activity or activities practiced within the Federation. This certificate may be issued by a general practitioner (downloadable model recommended: http://ffspeleo.fr/certif_medical). You may use a different medical certificate, but the disciplines must be expressly mentioned in the certificate under pain of nullity.

This MEDICAL CERTIFICATE must be attached to the license application sent to the FFS headquarters.
